**RE: Urging Sanctions and Action to Prevent Iran's Access to Funds Following Iran's Unprecedented April 13, 2024, Attack on the Nation of Israel**

Dear Secretary Blinken:

The American Center for Law and Justice (ACLJ) is a not-for-profit 501(c)(3) organization dedicated to the defense of constitutional liberties secured by law. The ACLJ regularly monitors and informs the public about governmental activity. The ACLJ and its global affiliated organizations – including the European Centre for Law and Justice credentialed with Special Consultative Status at the UN ECOSOC – are committed to defending the national security of the United States and that of its critical ally Israel, as well as the ongoing viability of freedom and liberty in the United States and around the world.

As the world watched on the Saturday night and Sunday morning of April 13-14, 2024, Iran launched an air assault of approximately 300 missiles and drones at our ally, the sovereign nation of Israel. In the aftermath of that attack, we urge swift and meaningful action in enforcing existing sanctions and issuing new ones to hold Iran accountable. The United States should use all legislative and executive authorities at its disposal to punish and deter Iranian terror, atrocities, and acts of war. More specifically, we urge you to take all actions necessary to ensure that Iran is permanently denied *any* access to the \$6 billion in funds currently held in Qatar, as addressed below. As you know, money is fungible, and any money given to the radical Iranian regime by the United States inevitably frees up additional resources to fund terrorist attacks that further destabilize the Middle East.

Numerous examples of Iran's unlawful and disgusting behavior are widely known, but their most egregious acts are surveyed below. On October 7, 2023, Iran-backed Hamas invaded Israel in a surprise terror attack, brutally murdering, mutilating, and sexually assaulting approximately 1,200 Israeli and foreign civilians, as well as kidnapping approximately 250 hostages.

This attack did not happen in a vacuum. Instead, it came on the heels of a major U.S. concession. In September 2023, the Biden Administration issued a blanket waiver of sanctions for international banks to transfer \$6 billion in frozen Iranian money from South Korea to Qatar as part of a prisoner exchange made with the terror state.<sup>1</sup> Just weeks later, Hamas committed its barbaric terror attack funded and armed by Iran.

Following the terror attack, on October 12, 2023, this Administration stated that Iran will not be allowed to access the \$6 billion in funds that remained in Qatar and that the United States retained the right to freeze the account. According to Secretary of State Antony Blinken, “We have strict oversight of the funds and we retain the right to freeze them.”<sup>2</sup> He added that “the U.S. Treasury oversees any disbursement to ensure it is used only for humanitarian purposes.”<sup>3</sup> According to White House Spokesman Admiral John Kirby, “the money was intended to be disbursed ‘to approved vendors - that we approved - to go buy food, medicine and medical equipment, agricultural products, and ship it into Iran directly to the benefit of the Iranian people.’”<sup>4</sup> Many warned that the Biden Administration’s deal would embolden Iran and boost its economy and political leadership “when Iran poses a growing threat to U.S. troops and Mideast allies.”<sup>5</sup>

Even with the funds frozen in Qatar, in November 2023, this Administration “extended a sanctions waiver to allow Iran to access upwards of \$10 billion in electricity revenue once held in escrow in Iraq.”<sup>6</sup> Accordingly, “[t]he waiver allows Baghdad to continue purchasing electricity from Iran and, in a change from past policy, for Iran to convert its revenue into euros and draw on the money for budget imports out of Iraq and Oman.”<sup>7</sup> This Administration’s argument that funds generated from transactions are “not permitted to enter Iran” is refuted openly by Iran itself. According to President Ebrahim Raisi, Iran will use the money “wherever we need it.”<sup>8</sup> Obviously, Iran can use or benefit from additional funds without a single dollar “enter[ing] Iran.” Further, Iran has been known to evade sanctions, for example, by fraudulently claiming a transaction to be humanitarian or smuggling humanitarian goods abroad for profit.<sup>9</sup>

In January 2024, Iran-backed terrorists murdered three American troops and injured 25 more in an attack on a United States base in Jordan.<sup>10</sup> According to a March 2024 tally, Iran's proxies "attacked U.S. troops there 170 times since the Oct. 7 Hamas attack in Israel."<sup>11</sup> Reports regularly surface of Iran-backed groups assaulting maritime targets<sup>12</sup> and engaging in cyberattacks on United States infrastructure and interests<sup>13</sup>. Then, early on April 14, 2024, Iran brazenly launched more than 300 missiles at Israel, some from Iran itself and others from its proxies' locations in the region.<sup>14</sup> Clearly, the current status quo of American foreign policy concerning Iran is emboldening the terrorist state, not containing or weakening it.

Despite the clear failures of current policy approaches to Iran, the Administration "might again extend this month's sanctions waiver to the Islamic Republic of Iran that would result in as much as [another] \$10 billion funneled into Iran's coffers."<sup>15</sup> The White House has simultaneously stated that it is considering some new sanctions: "In the coming days, the United States will impose new sanctions targeting Iran, including its missile and drone program as well as new sanctions against entities supporting the Islamic Revolutionary Guard Corps (IRGC) and Iran's Defense Ministry."<sup>16</sup> While the bill signed into law yesterday broadened sanctions to include ports, vessels, and refineries knowingly processing or shipping Iranian crude oil in violation of existing sanctions is a step in the right direction, the current situation demands more, stronger, and clearer action. At a minimum, Iran should permanently be denied access to the \$6 billion currently held in a Qatari bank and all potential sanction waivers should be rejected. Alternatively, the funds held in Qatar should be revoked and repurposed to the U.S. Victims of State Sponsored Terrorism Fund. To the extent legislative action is necessary to accomplish this, we urge you to advance and support such legislation.


