**Re: Slovenia's Decision to Recognise a Palestinian State**

Your Excellency:

By way of introduction, the European Centre for Law and Justice (ECLJ) is a non-profit, non-governmental organisation dedicated to protecting human rights around the world. We are deeply concerned by your government's decision to recognise a Palestinian state. To say that such a decision lacks any legal basis and "rewards" terrorist organisations, such as Hamas and the Palestinian Islamic Jihad (PIJ), would be to severely understate its gravity and repercussions. Similar decisions by Norway, Ireland, and Spain have already encouraged and empowered these terrorist groups to continue acting on their clearly stated<sup>1</sup> and demonstrated intent to destroy Israel and to continue their barbaric attacks on innocent Israeli men, women, children, and the elderly. The recognition by your government of a Palestinian state would also encourage the Palestinian Authority (PA) leaders to forego negotiations they have agreed to with Israeli leaders. The PA also lacks control over the Gaza Strip and Hamas's genocidal campaign against Israel and, thus, is not capable of governing a state.

We respectfully submit that Slovenian lawmakers' desire to "end the conflict" through recognising a Palestinian state is far from realistic. Such desire understandably arises from Slovenia's care about human life. Unfortunately, Hamas and other terrorist groups operating in Gaza do not care about human life. This was made clear on October 7, 2023. Yet, Slovenia, like Norway, Ireland, and Spain, did not understand Hamas's clearly visible plan but has played into Hamas's hands. The scale and nature of brutalities Hamas and other terrorist groups from the Gaza Strip committed on October 7, including continuing to hold hostages, clearly show that Hamas's intention was to invite a largescale armed response from Israel. By actively hiding in civilian areas and conducting operations from civilian facilities, Hamas purposefully put civilians in harm's way to cause such casualties. Hamas's plan was to garner the kind of misguided support Slovenia has just given.

Slovenia's decision is especially concerning because after Norway, Ireland, and Spain announced their decision to recognise a Palestinian state, a senior member of the Hamas political bureau, Bassem Naim, stated: "These successive recognitions are the direct result of this brave resistance and the legendary steadfastness of the Palestinian people."<sup>2</sup> Naim's reference to "brave resistance" does not mean peacefully living side by side with the State of Israel within the West Bank and the Gaza Strip. Hamas's "brave resistance" means the total destruction of the Jewish State. Hamas leadership continues to celebrate the "brave resistance" they displayed on October 7.<sup>3</sup>

Hamas further stated: "We consider this an important step towards affirming our right to our land."<sup>4</sup> As you know from Hamas's own statements,<sup>5</sup> the reference to "our right to our land" does not include just the West Bank and the Gaza Strip. "[O]ur right to our land" means a Palestinian state on the territory that includes the West Bank, the Gaza Strip, and the remaining land in the State of Israel.<sup>6</sup> Sadly and incomprehensibly, this is what Norway, Ireland, and Spain have recently supported. Sadly and incomprehensibly, this is what Slovenia has just supported.

Regardless of the pure intentions behind your government's decision, recognition of a Palestinian state will not end the conflict. Instead, it will encourage more unprovoked terrorist attacks like October 7, which will lead to greater civilian deaths on both sides. The world, including Norway, Spain, Ireland, and Slovenia, has seemingly already forgotten the brutal murders, rapes, mutilations, and horrific acts of torture Hamas committed on October 7. The world has also abandoned the Israeli hostages still under Hamas's control. We remind Slovenia that each one of these acts constitutes a war crime, crime against humanity, and genocide. Instead, the world is focused on incidental civilian casualties—a sad result of Hamas's unprovoked attack on Israeli civilians, not to mention that the civilians in Gaza are put in harm's way by Hamas's hiding in and conducting operations from civilian areas, a separate war crime.

If states like Slovenia were instead focused on pressuring Hamas to release the hostages, they would be on better ground to call for a peaceful resolution of the overall Israeli-Palestinian

conflict. It is not incomprehensible that if Hamas releases the hostages, Israel would be forced to pause the hostilities, and states like Slovenia would be in a better position to call for a peaceful resolution. To expect that recognising a Palestinian state in response to unapologetic brutal murders, mutilations, and rapes of civilians would bring about peace displays a lack of sound judgment.

While Slovenia might think that its recognition of a Palestinian state does not include supporting Hamas, the reality on the ground is different.<sup>7</sup> Until Hamas is eliminated, the terrorist organisation cannot be disassociated from the recognition of a Palestinian state. Reflecting the will of the Palestinian people, in 2006, Hamas won the Palestinian legislative elections.<sup>8</sup> PA President Mahmoud Abbas appointed Hamas leader, Ismail Haniyeh, as Prime Minister of Palestine.<sup>9</sup> In 2007, due to its dissension with the PA, Hamas took control of the Gaza Strip.<sup>10</sup> Since then, Hamas has conducted thousands of attacks against Israel. October 7 showed the true face of Hamas's "brave resistance" to the world. Until Hamas is eliminated, the reality is that Hamas is the governing authority in the Gaza Strip.<sup>11</sup>

Even if Slovenia theoretically excludes Hamas from its idea of a Palestinian state and sees the PA as the sole legitimate government of such a state, such aspirations also ignore the facts on the ground. In light of the barbaric Hamas attacks of October 7 on innocent men, women, and children, the PA clearly cannot control a large portion of the so-called "Palestinian state" including the terrorist organisations operating there. Based on the widespread celebrations of Palestinians in Gaza, the West Bank, and elsewhere of Hamas's indiscriminate acts of murder, rape, torture, desecration of bodies, and kidnapping of innocent Israelis, it is clear that the Palestinians, including the PA, are neither willing nor able to work with Israel peacefully to resolve their outstanding issues and create a real, recognisable state. Abbas Zaki, a senior member of the Fatah Central Committee, stated that creating a Palestinian state in the 1967 borders would spell Israel's doom.<sup>12</sup> Furthermore, while President Abbas makes statements about peace and a two-state solution, Palestinian teachers and media are indoctrinating their children to believe that Israel does not even exist.<sup>13</sup> In fact, the logo of the Palestinian Liberation Organisation (PLO) omits Israel completely from the territory of the former

Palestine Mandate, signifying Palestinian refusal to recognise Israel's legitimate existence.<sup>14</sup> This open stance against Israel by the PA, coupled with Hamas's recent unbelievable barbarism, makes it exceedingly obvious that Palestinians are currently incapable of assuming the burdens of responsible statehood, or coexisting peacefully with Israel.

Legally speaking, the 1949 *armistice lines* are often incorrectly referred to as the pre-1967 borders. They have never been regarded as international boundaries. From 1949 until 1967, the portions of territory of the Mandate for Palestine not under the control of the State of Israel remained under unlawful belligerent military occupation by Egyptian and Jordanian armed forces. For the eighteen years of the Egyptian and Jordanian unlawful occupation of the Gaza Strip and the West Bank, respectively, no Arab Palestinian state was formed. As a result of the 1967 Arab-Israeli war, Jordanian and Egyptian forces retreated from the West Bank and Gaza Strip and Israel rightfully acquired control of those areas.

Moreover, United Nations Security Council Resolution 242 adopted after 1967 required secure boundaries<sup>15</sup>—something that did not exist prior to 1967, as evidenced by the persistent attacks mounted against Israel from Arab-controlled areas, and would not exist today if the *status quo ante* were reinstated. The Resolution also called for the termination of all “states of belligerency and respect for and acknowledgement of the sovereignty, territorial integrity and political independence of every State in the area,”<sup>16</sup> something that Hamas has consistently and flagrantly violated by launching indiscriminate attacks on Israeli civilian population centres.

Further, each of the principles set forth in Resolution 242 is predicated on negotiations between Israel and its neighbours. Recognition of a Palestinian state without such negotiations between the parties would encourage the Palestinians to forego any concessions negotiations require to determine what a future Arab Palestinian state would look like. Instead of supporting the terms of Resolution 242, your government's recognition of a Palestinian state undermines them and puts both Palestinians and Israelis in danger.

It is only through direct negotiations between the parties that a just and lasting peace can be achieved. If states continue to recognise a Palestinian state without any consequences for the Palestinian leaders who committed horrific and brutal acts of murder, rape, mutilation, torture, and kidnapping, it sets back the Palestinian cause, encourages the terrorist groups to continue their genocidal attacks on Israel, and runs counter to the principles Slovenia has committed to under the UN Charter.

Until Palestinians negotiate in good faith, unequivocally denounce Hamas and other terrorist organisations that are bent on eliminating Jews and Israel, acknowledge Israel's right to exist, and the terrorist organisations stop targeting defenseless civilians and cease committing war crimes against both Israelis and their fellow Palestinians in Gaza, any recognition of a



Palestinian state will make those states that support it complicit in the serious crimes the terrorist organisations are committing.

We humbly request Slovenia's government to reconsider its decision to recognise a Palestinian state and instead pursue a strategy that has a potential to actually bring about peace.
