**RE: NPRA Request for records from the Nevada State Board of Medical Examiners

Dear Public Records Custodian:

Pursuant to the Nevada Public Records Act, NEV. REV. STAT. ANN. § 239.010 et seq. (LexisNexis, LEXIS through 2023 Reg. Sess.), the American Center for Law and Justice (ACLJ)¹ requests your records from the Nevada State Board of Medical Examiners Allegations regarding Dr. Hadiza Hamza.

For purposes of this Request, and unless otherwise indicated, the timeframe of records requested herein is January 1, 2022, through the date of receipt of this Request. All terms used herein have the definitions given by NEV. REV. STAT. ANN. § 239.010 et seq. (LexisNexis, LEXIS through 2023 Reg. Sess.) and subsequent precedent.

The ACLJ requests copies the following records be provided via email:

1. All public records including emails prepared or generated by any member of the Nevada State Board of Medical Examiners contemporaneous with the timeframe of this request that in any way concern Dr. Hadiza Hamza since January 1, 2022, to the date of processing this request, using the search string: “Dr. Hamza” or “Hamza” or “Hadiza”.
2. All public records including emails prepared or generated by any past or current member of the Nevada State Board of Medical Examiners that in any way concern Dr. Adam Levy since January 1, 2022, to the date of processing this request, using the search string: “Dr. Levy” or “Levy” or “Adam”.

¹ The ACLJ is a not-for-profit 501(c) (3) organization dedicated to the defense of constitutional liberties secured by law. The ACLJ regularly monitors governmental activity concerning abortion and works to inform the public of such affairs. 


