Pursuant to the Arizona Public Records Law, ARIZ. REV. STAT. § 39.101 et seq. (LexisNexis, LEXIS through 2022 Reg. Sess.), the American Center for Law and Justice (ACLJ)¹ requests your records regarding Secretary of State Katie Hobbs's communications with Twitter (also known as X), Facebook (also known as Meta), Google (also known as Alphabet) or Instagram from January 7, 2019 to January 1, 2023.

For purposes of this Request, and unless otherwise indicated, the timeframe of records requested herein is <u>January 7, 2019 through January 1, 2023</u>. All terms used herein have the definitions given by ARIZ. REV. STAT. §§ 39.101, et seq. (LexisNexis, LEXIS through 2022 Reg. Sess.) and subsequent precedent.

The ACLJ requests that copies of the following records be provided by email:

- 1. All records such as emails, direct messages, instant messages, or texts prepared or generated by or sent between Katie Hobbs and Twitter (also known as X), Facebook (also known as Meta), Google (also known as Alphabet) or Instagram from January 7, 2019 to January 1, 2023.
- 2. All records such as emails, direct messages, instant messages, or texts prepared or

Statement of Purpose


