Your Excellencies:

- 1. Pursuant to Rule 103(1) of the Rules of Procedure and Evidence (RPE) and the Pre-Trial Chamber I's order dated 27 June 2024, regarding the United Kingdom's request to provide observations pursuant to Rule 103(1),¹ the European Centre for Law and Justice (ECLJ) hereby requests leave to submit observations as *amicus curiae* to assist Your Excellencies regarding "[w]hether the Court can exercise jurisdiction over Israeli nationals, in circumstances where Palestine cannot exercise criminal jurisdiction over Israeli nationals pursuant to the Oslo Accords",² the validity of the Oslo Accords, and the scope of criminal jurisdiction under the Accords.
- 2. As the Chamber has already noted, the ECLJ is also of the view that this issue is of "potential relevance" in making an initial determination of jurisdiction at this stage of the proceedings in resolving the application for arrest warrants.⁴ To that end, the ECLJ would respectfully like to assist Your Excellencies by providing *amicus curiae* observations.
- 3. We believe that, given our past contribution to the work of the Court,⁵ including in the Situation in the State of Palestine and the Situation in the Islamic Republic of Afghanistan, the ECLJ's *amicus curiae* observations will assist Your Excellencies in making a just and proper determination of the matters before the Chamber.

- 4. The ECLJ is a non-profit organisation located in Strasbourg, France, dedicated, *inter alia*, to establishing and strengthening the rule of law in world affairs. The ECLJ is well-versed in matters of international law, has been following the Israeli-Palestinian conflict closely for decades, has engaged with the Office of the Prosecutor (OTP) on several occasions, ⁶ including participating in an in-person dialogue with the OTP regarding Palestinian Authority's accession to the Rome Statute, and has assisted the Court before by submitting a number of *amicus curiae* observations regarding issues similar to the ones before the Chamber. ⁷ The ECLJ also holds Special Consultative status before the United Nations Economic and Social Council. ⁸
- 5. WHEREFORE, in light of the foregoing, the ECLJ respectfully requests the Chamber to grant the ECLJ leave to submit *amicus curiae* observations pursuant to Rule 103(1) of the RPE.
