**STIPULATED ORDER EXTENDING
SHOW CAUSE ORDER/TEMPORARY RESTRAINING ORDER**

On June 6, 2010, this Court entered a Show Cause Order, (Docket Entry No. 7), granting plaintiff R.H.'s motion for a temporary order and setting a hearing on plaintiff's motion for a preliminary injunction for June 11, 2010.


The parties stipulate that the Show Cause Order/Temporary Restraining Order shall be extended through and including September 10, 2010, as the parties work to resolve this matter over the summer, and that defendants shall not impose discipline, including but not limited to detention, on plaintiff R.H. as a result of his wearing his rosary outside his clothing and in plain sight or as a result of him asserting his rights in this proceeding.

Accordingly, this Court orders that through and including September 10, 2010, defendants and their agents, servants, employees, attorneys, officers, and successors in office, and all those persons in active concert or participation with them, are enjoined from preventing plaintiff R.H. from attending public school in the Schenectady City School District while wearing a rosary outside his clothing and in plain sight and from imposing discipline, including but not limited to detention, on plaintiff R.H. as a result of his wearing his rosary outside his

clothing and in plain sight or as a result of him asserting his rights in this proceeding.

Should further proceedings be necessary on this matter, this Court will issue a separate order. The above-referenced June 11 hearing is cancelled. ^{rescheduled} For Wednesday, September 8, 2010
